MEMORANDUM FOR RECORD

SUBJECT: 2010 Joint Services Reserve Component Facility Board – Wyoming Minutes

1. **Convening of the Board:** In accordance with DOD Directive 1225.7 dated June 6, 2001, the JSRCFB was convened at 1300 hours, on 14 OCT 2009, at the Wyoming Army National Guard CFMO located at 3919 Central Ave., Cheyenne, WY 82001.

3. **Action of minutes of Previous Board:** The board reviewed the minutes of the previous board held 20 February 2008. A motion to accept the minutes was raised and seconded. The only actionable item was a follow-up on the building of the Joint Forces Readiness Center being constructed for Army and Air National Guard personnel on FEW. This (BRAC funded) facility is nearing 50% completion.

- a. Number of Projects Reviewed; twenty-four (24).
- b. Number of Projects recommended for joint construction; three (3).
- c. Number of Projects recommended for unilateral construction; twenty-one (21).
- d. Number of Projects NOT recommend for construction; zero (0).

6. **Project Recommendations:**

- a. There were 21 projects accepted for unilateral construction.
- b. There were 3 projects accepted or recommended for Joint Construction; two (2) of these were Maintenance Facilities that could be combined into one “General Maintenance” facility shared by both the ARNG and USAR in Casper, WY (56A10). The last shared project is based on an opportunity for the USNR to station an engineer element; detachment or section, at Camp Guernsey and the Regional Training Institute (560060) could be a project for joint consideration.

The two (2) locations for address were; the FEW Army Aviation Support Facility – C/5/159 Readiness Center (FYDP 2013) project (USAR and Marine element) and Camp Guernsey as noted in paragraph six (6).

8. Next Meeting: Conducted in Cheyenne, WY, 1300, 7 OCT 2010.

9. Adjournment: All business was completed by 1500 (MST) and the board adjourned.
